Mix 2:1 with **ProMIX Eclipse EMSS, EMSN & EMSF** activators Pot life: 5h at 20°C



5-10% **ProMIX Eclipse ENT, EFT & EST** thinners 16-18s / DIN 4 mm / 20 $^{\circ}C$



Compliant 1.3 – 1.5 mm 2.0 - 2.5 bar inlet pressure 2 coats 50–60µm



HVLP 1.3 – 1.5 mm 0.7 bar atomization pressure 2 coats 50–60µm



Wait 10 min before increasing temperature Bake 20 min at 60 °C panel temperature



Short Wave 8 min
The object should be maintained at greater than 60cm from source.
